Context	Fingal Public Participation Network (PPN) is a prescribed body / notified body in relation to An Bord Pleanála Reference : PL06F.304624. Fingal PPN is a Fingal wide network of over 800 community, voluntary, social inclusion and environment groups across the county.

1. Broadmeadow Way Initiative

The Fingal PPN welcomes the Broadmeadow Way initiative.

This initiative has the potential to enable cycling as a viable alternative to the private car as a mode of transit. As there is a climate emergency, this initiative has the potential to be a game-changer for commuters.

We would suggest that the plan includes improved linkages to the townlands of Malahide and Donabate. This would enable local residents to use the cycle way as a viable alternative to the private car.

The PPN also acknowledges the capacity of this initiative to add to the tourism offering of Fingal. The initiative has clear benefits for the social, economic and cultural development of the county, including significant community gain for the surrounding communities.

The PPN would specifically welcome engagement from the Broadmeadow Way project team at each stage of the project as it progresses and is realised, in particular through its Climate Change, Environment and Water Linkage Group and its Housing, Planning and Transport Linkage Group.
