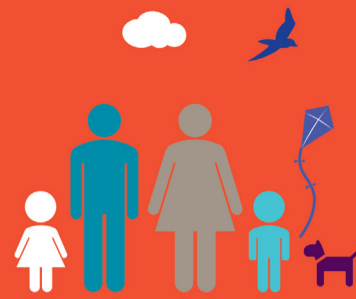

## Notice of the Preparation of the Draft Fingal Development Plan 2017 – 2023

NOTICE is hereby given, that pursuant to Section 12 (1) (b) of the Planning and Development Act, 2000 (as amended), that the Council of the County of Fingal being the Planning Authority for the County of Fingal, has prepared in accordance with the provisions of the above Act, a Draft Fingal Development Plan for the County of Fingal.

The Draft Plan is accompanied by an Environmental Report, prepared in accordance with the Planning and Development (Strategic Environmental Assessment) Regulations 2004 and an Appropriate Assessment, pursuant to Article 6 of the Habitats Directive 92/43/EEC.

All submissions or observations with respect to the Draft Development Plan 2017 – 2023 will form part of the statutory Chief Executive's Report to be presented to the full Council. Please be aware that this will include the names and addresses of those making the submissions or observations. Accordingly, the report and its contents will be included in the minutes of that meeting and consequently will be published on our website.
