Flemington Local Area Plan

The proposed LAP boundary has been designated in the Fingal County Development Plan 2023-2029. Flemington is located in north Balbriggan, approximately 1.5km northwest of Balbriggan town centre and 2.5km northeast of Junction 6 of the M1 motorway. The land is within the Balbriggan development boundary, is zoned RA – Residential Area and extends to 17.5 ha.

Local Area Plans play an important role in setting the framework for the achievement of integrated and balanced communities within a specified area. They seek to provide the optimal development framework to ensure the protection and enhancement of the existing areas, key features and the environment within an area, while providing for a high quality living environment through the use of robust urban design principles.

Public Participation

FCC has commenced an extensive consultation process which is a key feature of the Local Area Plan process.

The vision for the RA zoning objective and LAP seeks to ensure the provision of high quality new residential environments with good layout and design, with adequate public transport and cycle links and within walking distance of community facilities and provide an appropriate mix of house sizes, types and tenures in order to meet household needs and to promote balanced communities.

A Consultant Team was appointed to aid Fingal County Council in the drafting and consultation process of the LAP and local input is vital. We value what you have to say.


