#### Framework Plan for Clonsilla

The proposed FP boundary has been designated in the Fingal Development Plan 2023-2029 and includes an area of land south of Clonsilla Road/Larch Grove, bounded by Diswellstown Road to the east, Callaghan Bridge to the west and extends just south of the railway tracks.

The FP will provide a vision for the improvement and enhancement of Clonsilla Village. The Plan will highlight the following;

- Distinctive Character of Clonsilla.
- Current issues in Clonsilla.
- Actions required to encourage the rejuvenation and revitalisation of Clonsilla village centre.

### **Public Participation**

FCC has commenced an extensive consultation process which is a key feature of the Framework Plan process.

The FP will be a proactive plan intended to manage and influence village centre improvement in Clonsilla and act as a starting point for future funding opportunities and works within the study area.

This FP seeks to facilitate the revitalisation and improvement of Clonsilla and enhance the village centre and community infrastructure to serve existing and future communities.

#### **Having Your Say: Your Role**

We value what you have to say as local input is vital in the consultation process and helps in the drafting of the FP.
