



## **NOTICE OF PRE-DRAFT CONSULTATION IN RELATION TO THE REVIEW OF DUBLIN AIRPORT LOCAL AREA PLAN.**

### **NOTICE UNDER SECTION 20(1) OF THE PLANNING AND DEVELOPMENT ACTS 2000 (AS AMENDED).**

Notice is hereby given that Fingal County Council intends to review the existing Dublin Airport Local Area Plan and prepare a new Local Area Plan for Dublin Airport.

The purpose of this notice is to engage with the public and other stakeholder bodies, before preparation commences, on the critical issues to be addressed and explored in the Local Area Plan. Dublin Airport is the principle gateway to Ireland and the upcoming Local Area Plan will aim to reflect this important economic entity whilst also addressing the needs of the local communities in the vicinity.

#### **Strategic Issues Paper**

To assist in this Pre-Draft public consultation, an Issues Paper has been developed to present an overview of issues, inform the public and encourage debate on what broad issues should be considered in the Plan review. All submissions should include your name and a contact address, and where relevant, details of any organisation, community group or company etc., which you represent. To assist Fingal County Council in complying with data protection legislation, you are asked to provide this information on a separate sheet. Details, including the names of those making submissions may be shared with relevant Council departments or their agents involved in the making of the Local Area Plan and may form part of reports linked to the making of the Local Area Plan.

#### **Submission Deadline**

Submissions on the Dublin Airport Local Area Plan Strategic Issues Paper will be accepted from **Tuesday 26th June until Tuesday 21st August** (both dates inclusive). **Please note that late submissions cannot be accepted.** Written submissions or observations with respect to the Dublin Airport Local Area Plan review, made to the Planning Authority within the stated period, will be taken into consideration before the making of the Draft Local Area Plan.
