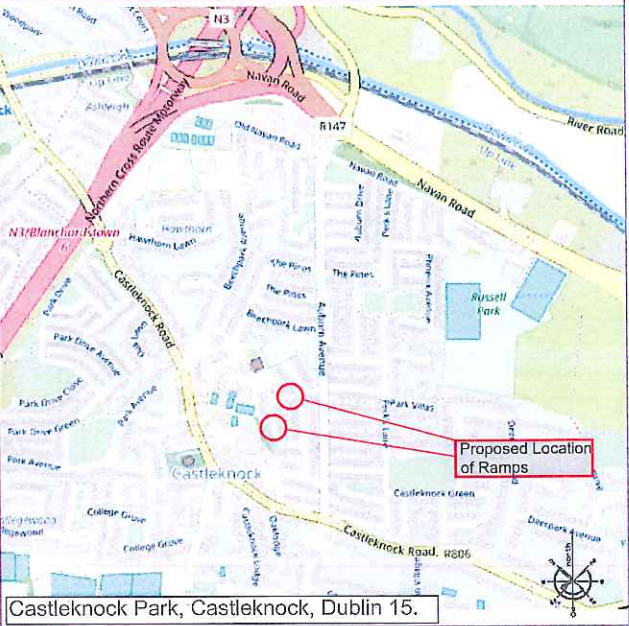

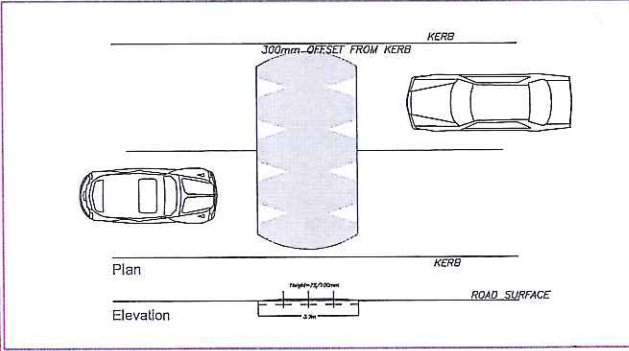

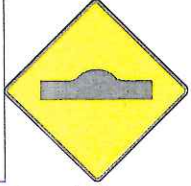
Site Layout
