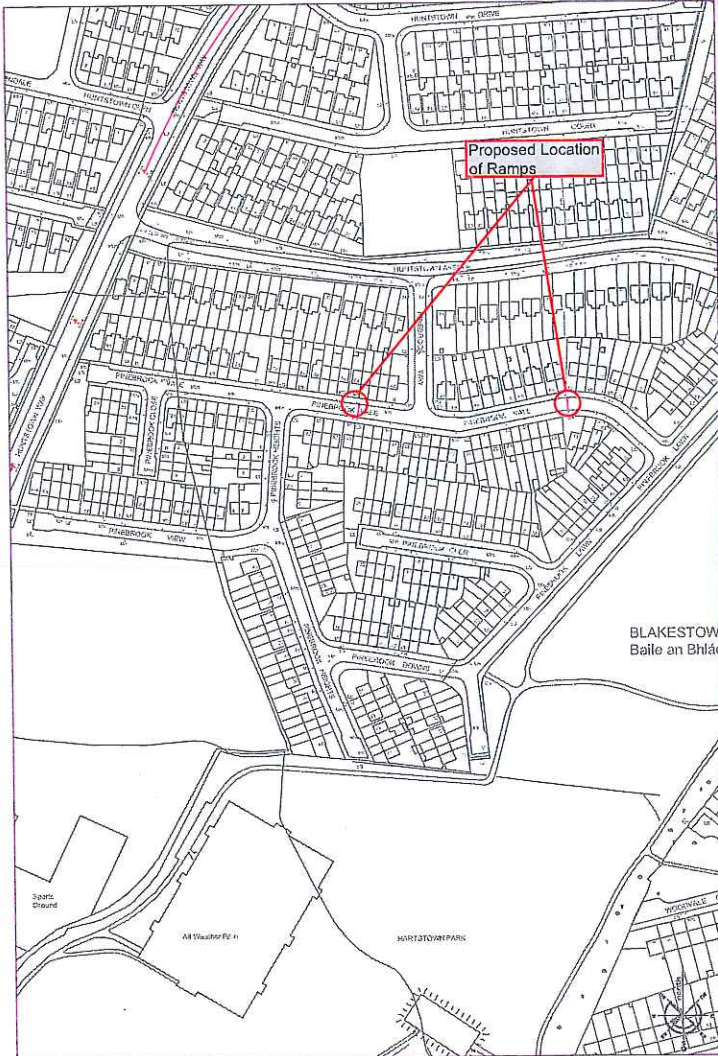

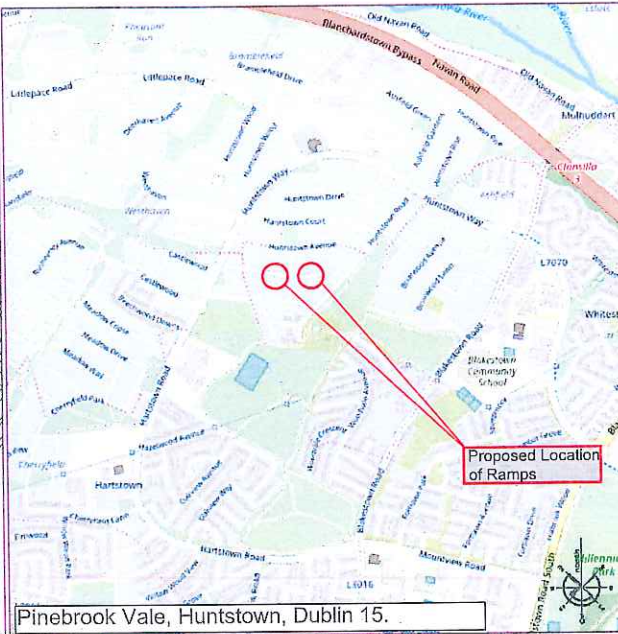

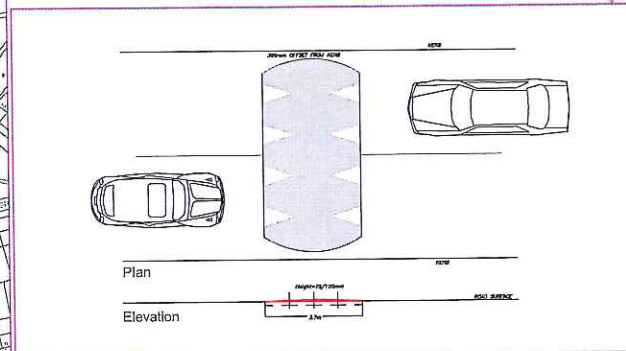


Site Layout

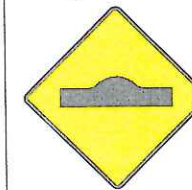


Pinebrook Vale, Huntstown, Dublin 15.
