**TRAFFIC CALMING SCHEME**

**Balrothery, Co. Dublin.**

Fingal County Council in exercise of the powers conferred under Section 38 of the Road Traffic Act, 1994 and Section 46 of the Public Transport Regulation Act, 2009 hereby gives notice that it has prepared a further Traffic Management Scheme for Balrothery, Co. Dublin.

The scheme includes the following:

- Creating a priority T-Junction at Darcystown Road/ Coach Road which will entail buildouts to the footpaths on both sides of Darcystown Road, removal of the roundabout, associated road markings and signage
- 2 No. Road Cushions and associated road markings and signage along Knightswood
- A 3 tonne ban on all approaches to Balrothery Village
