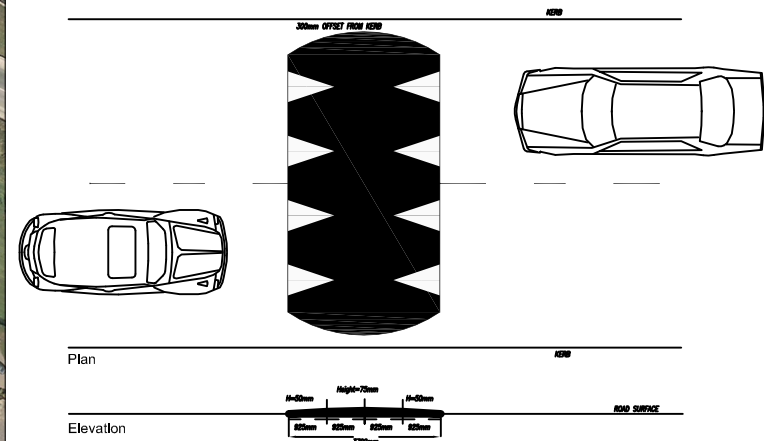

LEGEND:

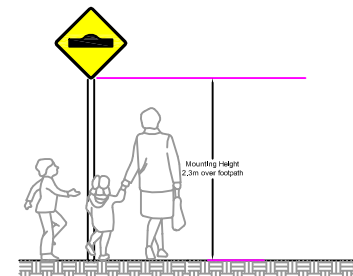


PROPOSED TRAFFIC CALMING RAMP
