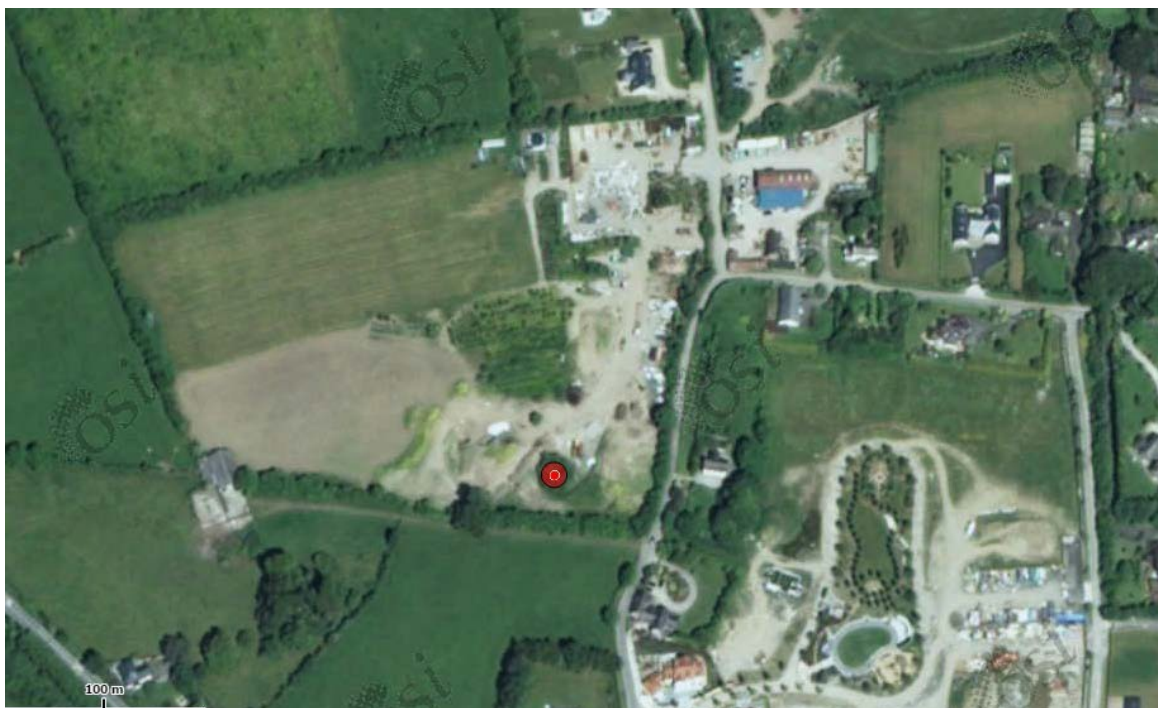

Excavated in 1982. Probably the remains of an ornamental garden feature. There are no structural remains present to warrant retention in the Record of Protected Structures. Alternative protection for the mound site exists under the National Monuments Acts 1930-2004, as a Record Monument RMP Ref No. DU012-028.

RECOMMENDATION: It is recommended that Mound, Streamstown Lane, Auburn, Co. Dublin is deleted from the Record of Protected Structures.



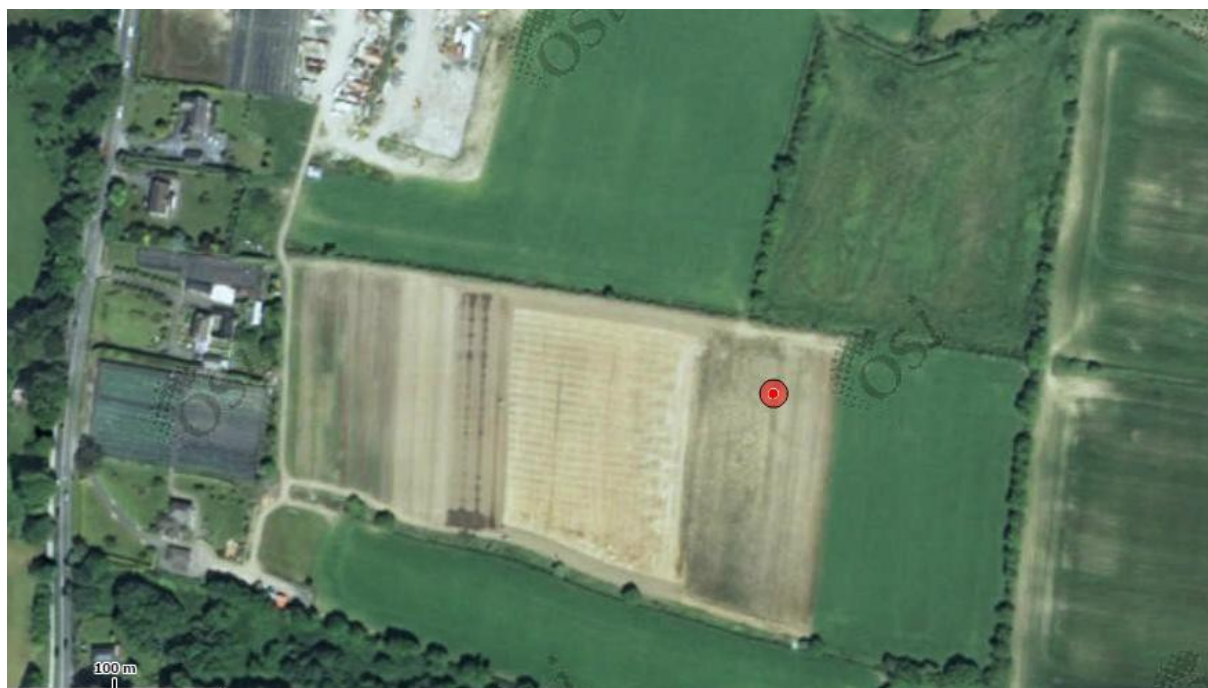

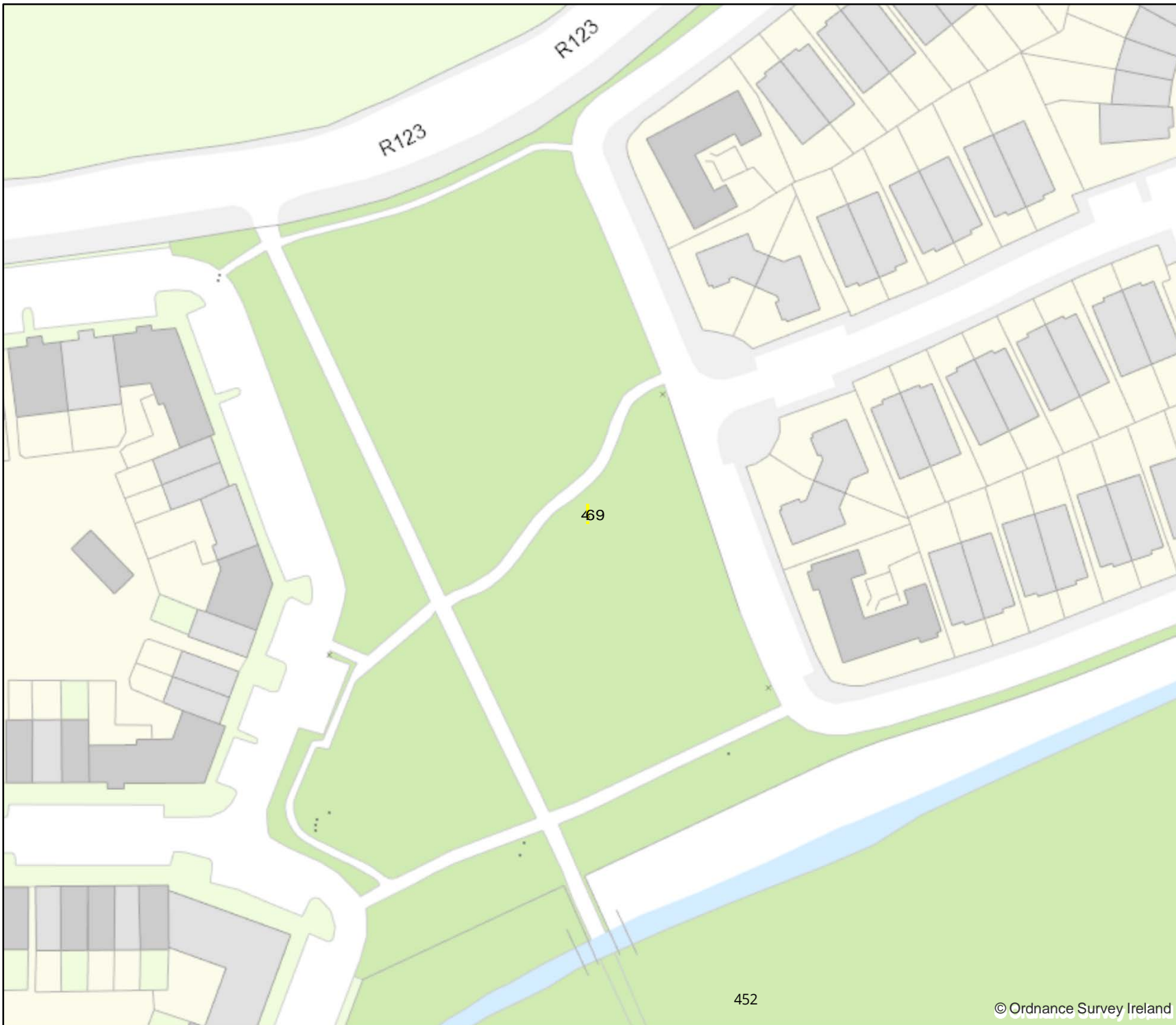
Description

Appraisal

A historical record from 1630 describes the church and chancel as ruins. Archaeological investigations and excavations took place in 2003 and 2004 that revealed subsurface features and artefacts. There are no structural remains present above ground to warrant retention in the Record of Protected Structures. Alternative protection for Balgriffin Church site exists under the National Monuments Acts 1930-2004, as a Record Monument RMP Ref No. DU015-012001.

RECOMMENDATION: It is recommended that Balgriffin Park Church, off Balgriffin Road, Balgriffin Park, Co. Dublin is deleted from the Record of Protected Structures.

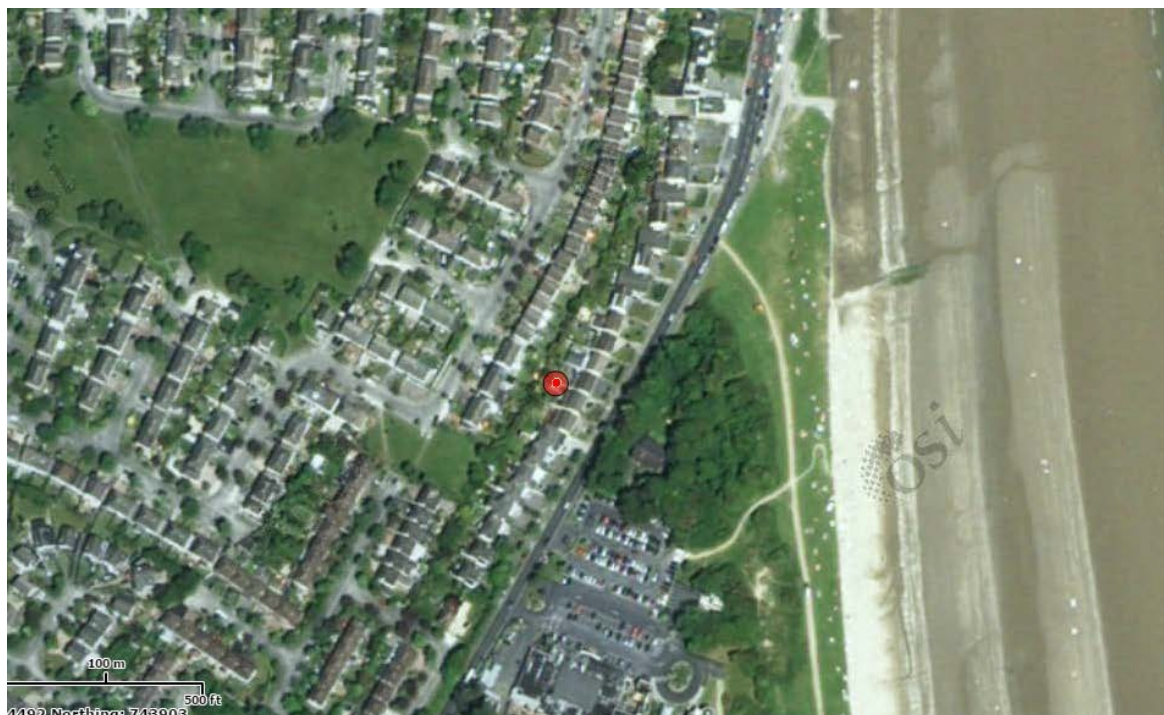

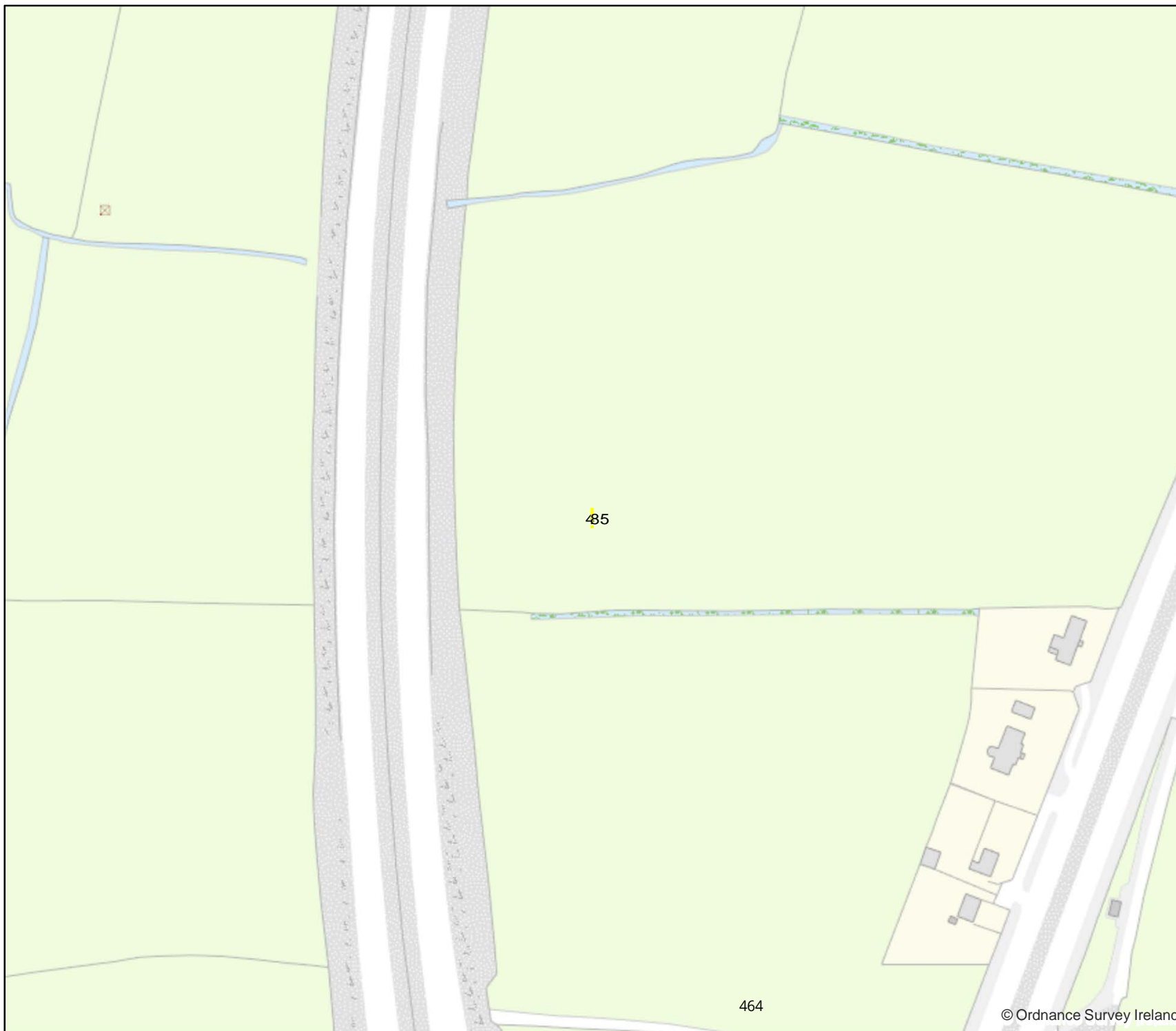

Appraisal

A thatched Castle held by Laurence Bealing is listed in the Civil Survey of 1654 to 1656. There is no trace of the castle above ground and the site is under a large commercial shed. The enclosure sites were investigated with test excavations in 2008. There are no visible traces at ground level. There are no structural remains present above ground to warrant retention in the Record of Protected Structures. Alternative protection for the Castle Site and enclosure exists under the National Monuments Acts 1930-2004, as a Record Monument RMP Ref No. DU011-007001 + DU012-001.

RECOMMENDATION: It is recommended that Castle Site and Enclosure, Batter Lane, off N1 Road, Belinstown, Co. Dublin is deleted from the Record of Protected Structures.
