There are no structural remains present above ground to warrant retention in the Record of Protected Structures. Alternative protection for the Ringfort Site exists under the National Monuments Acts 1930-2004, as a Record Monument RMP Ref No. DU014-022.

RECOMMENDATION: It is recommended that Ringfort Site, St. Margaret's Road, Balcurris, Co. Dublin is deleted from the Record of Protected Structures.
