Information Leaflet

on the Public Consultation of the External Emergency Plan

From 09:30 to 16:30 hrs daily, from Thursday 1st February, 2018 to Friday 2nd March, 2018 inclusive, excluding weekends

An Garda Síochána, the Health Service Executive, and Fingal County Councils are each required by the Chemicals Act (Control of Major Accident Hazards Involving Dangerous Substances) Regulations 2015 (S.I. no. 209 of 2015) to prepare a plan (External Emergency Plan) to deal with effects off-site and to assist, where relevant, with the emergency response on-site in the event of a major accident at:

Chemco Ireland Limited, Damastown Avenue, Damastown Industrial Park,
Mulhuddart, Dublin 15

In the unlikely event of a major accident on this site, you will hear an “air raid” siren, which may mean there has been a major emergency on site. We wish to advise you of the steps to be taken when hearing the siren, as well as reminding you to follow any instructions which will be issued during the incident by the Emergency Services:

- Remain calm.
- Go indoors and remain inside.
- Ensure doors and windows are tightly shut.
- Listen to the local radio.
- Switch off any ventilation systems to avoid the intake of harmful emissions from outside. Odours, which may be quite noticeable at your residence, will not be strong enough in concentration to be ignitable by electrical switches.
- Do not leave the area – if there is any need to do so An Garda Síochána will issue the appropriate instructions.
- Wait for and follow any instructions from the Emergency Services.
